

# Private records agents and researchers

The Grainger Museum receives research enquiries from all over the world seeking to access the rich and varied collection. The collection catalogue is available online on the Museum's website (<a href="www.grainger.unimelb.edu.au">www.grainger.unimelb.edu.au</a>) and material from the collection is made available to researchers in the Cultural Collections Reading Room, on the 3<sup>rd</sup> floor of the Baillieu Library.

Where researchers are unable to attend the Museum or Reading Room in person, they may wish to engage a private records agent and researcher to undertake research at the Museum on their behalf.

To facilitate access to the collection in this way, the Museum maintains a list of individuals who can be contacted to undertake research of this kind. Whilst the Museum attempts to keep this list up to date and accurate, is it wholly dependent upon the private records agents and researchers for the information therein. This list does not indicate any form of accreditation or recognition by the Grainger Museum. All conditions and service charges must be negotiated directly with the selected private records agent and researcher. It is important to note that the Grainger Museum is not a party to any of these wholly private arrangements nor does it endorse or take responsibility for individuals or transactions.
